PRESIDENT'S REPORT



As you may be aware this is my final year as President of the club. I have had the privilege of working with some very talented and committed people, not the least being my fellow Board members who have worked tirelessly to make sure we have a club now but also into the future. In the past three years we have all been touched by Covid and the restrictions and limitations it has had on our lives. We have emerged out of the pandemic I think stronger, wiser and more in touch with a work-life balance. It has made seasons seem twice as long with the challenges it threw at us, but we got through it together.

Just to reiterate, I'd like to thank the Board and their supporting teams as without their efforts we would not have an operational club. Your work, commitment and supporting families are greatly appreciated, and I thank you not only from my perspective but on behalf of all club members. I'd also like to take this opportunity in wishing the future Board all the success, we have a wonderful club that provides a great service to the broader community and we must not lose focus of our key operational responsibilities.

It would be remiss of me also not to thank the important jobs many people play on the beach and within the club over summer. Our Patrol Captains, Vice Captains and Patrol Leadership teams, lifesaver volunteers, Nipper volunteers, kiosk people, maintenance etc. It takes so many people to keep the club running.

The young and older leaders within our Club combined with the Surf Lifesaving volunteers are responsible for keeping the community safe, providing first aid and surf rescue, and distilling confidence in the public to use the beach and swim between the flags. Without their commitment and dedication, we would not be able to man the 4 patrol teams that make up our rosters. In addition, young people coming through look up to you, our volunteers, as role models, as one day they will fill your shoes.

Our sponsors are an important part of the Club's community, and without their generous support we would not be able to have such fantastic facilities and assets as we do. Thank you to all our sponsors continued support and we look forward to building future relationships.

This year we have replaced the deck and club house windows which has made a great improvement for the club. We live in a very harsh environment and continual replacements; maintenance and upkeep are required to keep the club looking good. ATVs last about 3 - 4 years, IRB motors and boats are continually replaced and not too far into the future we will be looking for a new Patrol Tower – that's life on the beach!

Nippers once again was a huge success for the Club. We had around 200 Nippers on the beach enjoying two weeks of fun, surf safety education and meeting new friends – with Covid safe practices in place. Lucy Chambers (once again) and her army of volunteers did a fantastic job. This year we put in place a Nipper Committee which allowed the 2 weeks to plan more and be ready for the season, this worked well, and I thank all who sat on that committee. A big thank you to the water safety kids who did an amazing role ensuring every nipper was looked after in the water. This program is so important to the club, it nurtures tomorrow's lifesavers and creates tomorrow's leaders. The smiles on the kid's faces on the beach says it all.

Another special event that takes some co-ordinating is our bronze camps. I am very proud of the young people who run these camps and the support they have behind the scenes. Again, this is the final step from Nippers, water safety, SRC to a qualified Bronze Surf Lifesaver. The life skills these young people learn from the course will carry them through their entire life, and they have a lot of fun and make strong friendships on the way. The trainers are a great bunch of people and I have thanked you before, but again a big thank you – you guys rock.

The bar has gone from strength to strength over the three years it has been open – another record season under the watchful eye of Glenn Arnold. Opened and commenced operation in December 2019 it has worked threefold. Firstly, by creating a place for members to catch up and leaving the kitchen free for patrols. Secondly it bought increased income into the Club. And thirdly and more importantly it allowed club members to engage with the community. We literally had hundreds of people off the beach, walking at night, or just driving by and seeing the open sign, who would never have been in the Club before. Also, this year we added sound acoustic ceiling tiles late in the season which allows us now to have music without the echo! A great addition.

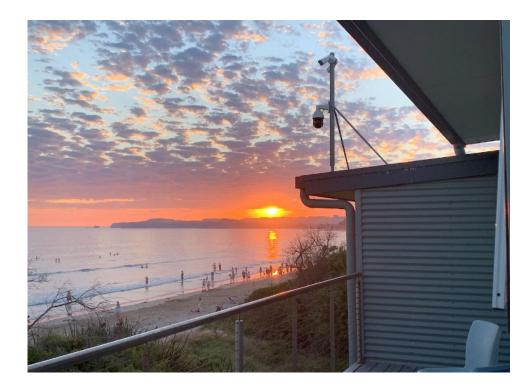
Disabled surfing has also been a regular on the club calendar and after two years of a hiatus with Covid was back bigger than ever in March and April. This is a real pet project of mine since 2017 when I was asked to take control of it. The experiences we give these people is only matched by the experience the army of volunteers who assist them in all forms on the day get out of it. I can honestly say it is one of the most rewarding experiences I have had. I encourage all to get involved – next year the DSA days will be held in Jan and Feb – much warmer for the participants. Be there!

On a final note, I would like to thank Alan Bolton and David Shultz who are jointly responsible for the clubhouse management. Their time and effort keeping the club looking so good, and managing accommodation, is outstanding, as is the many volunteers that give up their time.

Thank you for all your support during the 3 years I have been President, I believed holding the position was an honour and I tried to represent the club wherever I popped up with the greatest respect to the position and the club/lifesaving colours. I am not disappearing – I will continue to be of service to the club, participate in patrols, be licensee for the bar and generally having fun with you, like-minded people.

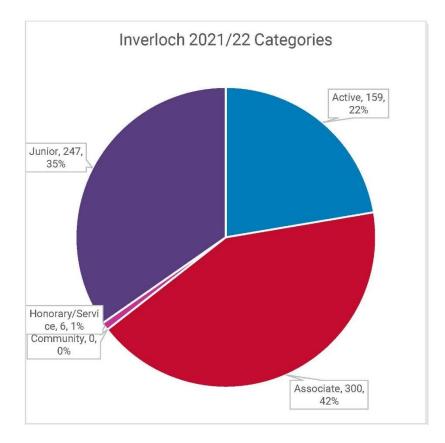

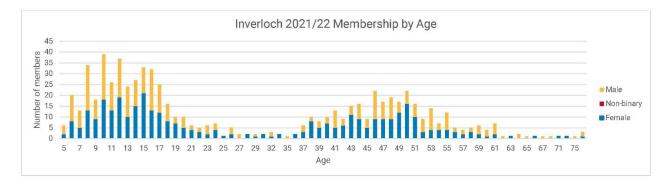

FINANCE & TREASURERS REPORT



Season 2021/22 seemed like a wash, rinse, repeat of season 2020/21 thanks to reducing lockdowns, not much overseas travel and a reasonable summer weatherwise. Whilst the initial financial numbers might seem a little low on previous years, we did in fact have a stellar year and more than held our own in light of some unexpected events.

Results:

Our "unadjusted totals" (before accounting smoke and mirrors) showed a small profit for the season of just over \$11k. At the end of the day it's only for recording and reporting purposes. The real story lies in our cash holdings as we really are a cash business in both accounting and financial terms.

The Till:

Our opening bank account totals started at \$249,947.65 We ran a full season and closed the year out with a final balance of \$235,369.62 An overall reduction in our cash position of \$14,578.03!!

Some wins:

The Deck Bar exceeded expected turnover by an additional 50% yielding a \$30K profit for the season. Our wonderful band of volunteers in the Kiosk ably led by Claudia not only beat last season's sales record of \$98K but smashed it out of the park with an additional \$10k in revenue making the summers turnover figures a whopping \$108k and change. I dare not think how many coffees, hot dogs and salad rolls this adds up to???

The streetwear collection of uniform went gang busters and sold out of the more popular sizes once again.

We also netted a cool \$68K in grants that paved the way for more motors, boards, first aid and other vital lifesaving equipment as well as running a normal lifesaving season.

The expected and the unexpected expenses:

At the end of the 2020 year the board approved the replacement of the external deck around the clubhouse. Quotes were submitted and funding for the \$80K project was obtained. Lock downs ensued, building material shortages started to bite and prices went north in a big hurry. What was to be an \$80K project turned into a \$130K fiasco!

The windows along the north face of the clubhouse needed replacing. The Aircons in the training room packed it in. The big fridge in the kitchen died after 10 years of faithful service. The garage door sustained \$2k worth of damage at Bronze Camp. All this came on top of our normal repairs and maintenance for the year. These minor inconveniences totalled some \$87K in R & M costs of which \$60K was unexpected and \$50K of that was unfunded from external sources such as grants.

The Real World:

We had another fantastic summer on the new and improved deck, which should last 20 years before it needs any attention. The new windows are in and looking classy. The big fridge, after receiving a new compressor is purring like a kitten once more and the garage door creaks and groans its way up and down just like it always does. All is right in the world today!!

From the Treasurer:

As we look back on the season, we can all see that the world is changing and the way we do things needs to change with it! The time has come for me to take a step back and let younger heads with fresh ideas lead the charge into the future. But I cannot go without acknowledging those dedicated souls that got us to where we are today.

Glenn Arnold and his big black folder of RSA's tending bar all summer and all season and making sure we so much enjoyed those balmy nights on the "new deck"! Bring on next summer please!!

Claudia Cox and the food preppers, drink makers and practicing barristers, (I think that should be barista's) thanks for all the hotdogs, cheese toasties and sweet chilli chicken wraps that fed me, my children and all the other patrollers over the course of the season. We could not survive the day without you there.

The trainers, assessors, coaches, mentors, uniform sellers, sausage cookers, cupcake bakers, sandwich makers, equipment fixers, icing mixers and those who emptied a bin, wiped a bench, stacked a dishwasher or turned off a light – you guys (in footy terms) are the 1% 'ers that make it a winning team. No glamour, no big cash deposits, just good old fashioned elbow grease, time served and smiles from those who know what you do!

Note 1: Summary of Significant Accounting Policies

Basis of Preparation

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporations Act. In the opinion of the committee the association is not a reporting entity because it is not reasonable to expect the existence of users who rely on the association's general purpose financial statements for information useful to them for making and evaluating decisions about the allocation of resources.

The financial report has been prepared in accordance with the Associations Incorporations Act, the basis of accounting specified by all Australian Accounting Standards and Interpretations, and the disclosure requirements of Accounting Standards AASB 101: Presentation of Financial Statements, AASB 107: Cash Flow Statements, AASB 108: Accounting Policies, Changes in Accounting Estimates and Errors, AASB 1031: Materiality and AASB 1054: Australian Additional Disclosures.

The association has concluded that the requirements set out in AASB 10 and AASB 128 are not applicable as the initial assessment on its interests in other entities indicated that it does not have any subsidiaries, associates or joint ventures. Hence, the financial statements comply with all the recognition and measurement requirements in Australian Accounting Standards.

The association has not assessed whether these special purpose financial statements comply with all the recognition and measurement requirements in Australian Accounting Standards.

The financial report has been prepared on an accrual basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

(a) Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The depreciation rates used for each class of depreciable asset are:

(b) Impairment of Assets

At the end of each reporting period, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the income statement.

(c) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

(d) Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

The association has applied AASB 15: Revenue from Contracts with Customers (AASB 15) and AASB 1058: Income of Not-for-Profit Entities (AASB 1058) using the cumulative effective method of initially applying AASB 15 and AASB 1058 as an adjustment to the opening balance of equity at 1 July 2019. Therefore, the comparative information has not been restated and continues to be presented under AASB 118: Revenue and AASB 1004: Contributions.

In the current year

Contributed Assets

The association receives assets from the government and other parties for nil or nominal consideration in order to further its objectives. These assets are recognised in accordance with the recognition requirements of other applicable accounting standards (eg. AASB 9, AASB 16, AASB 116 and AASB 138).

On initial recognition of an asset, the association recognises related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer).

The association recognises income immediately in profit or loss as the difference between initial carrying amount of the asset and the related amount.

Operating Grants, Donations and Bequests

When the association receives operating grant revenue, donations or bequests, it assesses whether the contract is enforceable and has sufficiently specific performance obligations in accordance with AASB 15.

When both these conditions are satisfied, the association:

- identifies each performance obligation relating to the grant

- recognises a contract liability for its obligations under the agreement

- recognises revenue as it satisfies its performance obligations.

Where the contract is not enforceable or does not have sufficiently specific performance obligations, the association:

- recognises the asset received in accordance with the recognition requirements of other applicable accounting standards (eg. AASB 9, AASB 16, AASB 116 and AASB 138)

- recognises related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer)

- recognises income immediately in profit or loss as the difference between the initial carrying amount of the asset and the related amount.

If a contract liability is recognised as a related amount above, the association recognises income in profit or loss when or as it satisfies its obligations under the contract.

Capital Grant

When the association receives a capital grant, it recognises a liability for the excess of the initial carrying amount of the financial asset received over any related amounts (being contributions by owners, lease liability, financial instruments, provisions, revenue or contract liability arising from a contract with a customer) recognised under other Australian Accounting Standards.

The association recognises income in profit or loss when or as the association satisfies its obligations under the terms of the grant.

Interest Income

Interest revenue is recognised using the effective interest rate method.

Dividend Income

The association recognises dividends in profit or loss only when the right to receive payment of the dividend is established.

Income from Sale of Goods

The association publishes and sells books and magazines publications to the general public. Revenue is recognised when control of the products has transferred to the customer. For such transactions, this is when the products are delivered to the customers. Volume discounts could be provided with the sale of these items, depending on the volume of aggregate sales made to eligible customers over every six-month period. Revenue from these sales is based on the price stipulated in the contract, net of the estimated volume discounts. The volume discounts are estimated using historical experience and applying the expected value method. Revenue is then only recognised to the extent that there is a high probability that a significant reversal of revenue will not occur. Where there is expected volume discounts payable to the customers for sales made until the end of the reporting period, a contract liability is recognised.

A receivable will be recognised when the goods are delivered. The association's right to consideration is deemed unconditional at this time as only the passage of time is required before payment of that consideration is due. There is no significant financing component because sales (which include those with volume discounts) are made within a credit term of 30 to 45 days.

Customers have a right to return products within 60 days as stipulated in the current contract terms. At the point of sale, a refund liability is recognised based on an estimate of the products expected to be returned, with a corresponding adjustment to revenue for these products.

Consistent with the recognition of the refund liability, the association further has a right to recover the product when customers exercise their right of return so consequently the company recognises a right to returned goods asset and a corresponding adjustment is made to cost of sales.

Historical experience of product returns is used to estimate of the number of returns on a portfolio level, using the expected value method. It is considered highly probable that significant reversal in the cumulative revenue will not occur given the consistency in the rate of return presented in the historical information.

All revenue is stated net of the amount of goods and services tax (GST).

In the comparative period

Non-reciprocal grant revenue was recognised in profit or loss when the association obtained control of the grant and it was probable that the economic benefits gained from the grant would flow to the entity and the amount of the grant could be measured reliably.

If conditions were attached to the grant which must be satisfied before the association was eligible to receive the contribution, the recognition of the grant as revenue was deferred until those conditions were satisfied.

When grant revenue was received whereby the association incurred an obligation to deliver economic value directly back to the contributor, this was considered a reciprocal transaction and the grant revenue was recognised in the statement of financial position as a liability until the service had been delivered to the contributor; otherwise the grant was recognised as income on receipt.

The association received non-reciprocal contributions of assets from the government and other parties for no or nominal value.

These assets were recognised at fair value on the date of acquisition in the statement of financial position, with a corresponding amount of income recognised in the statement of profit or loss and other comprehensive income.

Donations and bequests were recognised as revenue when received.

Interest revenue was recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument.

Dividend revenue was recognised when the right to receive a dividend had been established.

Rental income from operating leases was recognised on a straight-line basis over the term of the relevant leases.

Revenue from the rendering of a service was recognised upon the delivery of the service to the customer.

(e) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

(f) Financial Assets

Initial recognition and measurement

Financial assets and financial liabilities are recognised when the association becomes a party to the contractual provisions of the instrument. For financial assets, this is equivalent to the date that the association commits itself to either purchase or sale of the asset (i.e. trade date accounting is adopted).

Financial instruments (except for trade receivables) are initially measured at fair value plus transaction costs, except where the instrument is classified "at fair value through profit or loss", in which case transaction costs are expensed to profit or loss immediately. Where available, quoted prices in an active market are used to determine fair value. In other circumstances, valuation techniques are adopted.

Trade receivables are initially measured at the transaction price if the trade receivables do not contain a significant financing component or if the practical expedient was applied as specified in paragraph 63 of AASB 15: Revenue from Contracts with Customers.

Classification and subsequent measurement

Financial assets are subsequently measured at:

- amortised cost

- fair value through other comprehensive income or

- fair value through profit or loss.

Measurement is on the basis of two primary criteria:

- the contractual cash flow characteristics of the financial asset and

- the business model for managing the financial assets.

A financial asset that meets the following conditions is subsequently measured at amortised cost:

- the financial asset is managed solely to collect contractual cash flows and

- the contractual terms within the financial asset give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding on specified dates.

A financial asset that meets the following conditions is subsequently measured at fair value through other comprehensive income:

- the contractual terms within the financial asset give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding on specified dates and

- the business model for managing the financial asset comprises both contractual cash flows collection and the selling of the financial asset.

By default, all other financial assets that do not meet the measurement conditions of amortised cost and fair value through other comprehensive income are subsequently measured at fair value through profit or loss.

The association initially designates a financial instrument as measured at fair value through profit or loss if:

- it eliminates or significantly reduces a measurement or recognition inconsistency (often referred to as an "accounting mismatch") that would otherwise arise from measuring assets or liabilities or recognising the gains and losses on them on different bases

— it is in accordance with the documented risk management or investment strategy and information about the groupings is documented appropriately, so the performance of the financial liability that is part of a group of financial liabilities or financial assets can be managed and evaluated consistently on a fair value basis and

- it is a hybrid contract that contains an embedded derivative that significantly modifies the cash flows otherwise required by the contract.

The initial measurement of financial instruments at fair value through profit or loss is a one-time option on initial classification and is irrevocable until the financial asset is derecognised.

Derecognition

Derecognition of financial assets

A financial asset is derecognised when the holder's contractual rights to its cash flows expires, or the asset is transferred in such a way that all the risks and rewards of ownership are substantially transferred.

All the following criteria need to be satisfied for the derecognition of a financial asset:

- the right to receive cash flows from the asset has expired or been transferred

- all risk and rewards of ownership of the asset have been substantially transferred and

- the association no longer controls the asset (i.e. it has no practical ability to make unilateral decisions to sell the asset to a third party).

On derecognition of a financial asset measured at amortised cost, the difference between the asset's carrying amount and the sum of the consideration received and receivable is recognised in profit or loss.

On derecognition of a debt instrument classified as fair value through other comprehensive income, the cumulative gain or loss previously accumulated in the investment revaluation reserve is reclassified to profit or loss.

On derecognition of an investment in equity that the association elected to classify as at fair value through other comprehensive income, the cumulative gain or loss previously accumulated in the investments revaluation reserve is not reclassified to profit or loss, but is transferred to retained earnings.

Impairment

The association recognises a loss allowance for expected credit losses on:

- financial assets that are measured at amortised cost or fair value through other comprehensive income
- lease receivables
- contract assets (e.g. amount due from customers under contracts)
- loan commitments that are not measured at fair value through profit or loss and
- financial guarantee contracts that are not measured at fair value through profit or loss.
- Loss allowance is not recognised for:
- financial assets measured at fair value through profit or loss or
- equity instruments measured at fair value through other comprehensive income.

Expected credit losses are the probability-weighted estimate of credit losses over the expected life of a financial instrument. A credit loss is the difference between all contractual cash flows that are due and all cash flows expected to be received, all discounted at the original effective interest rate of the financial instrument.

The association uses the following approaches to impairment, as applicable under AASB 9: Financial Instruments:

- the general approach
- the simplified approach
- the purchased or originated credit-impaired approach and
- low credit risk operational simplification.

General approach

Under the general approach, at each reporting period, the association assesses whether the financial instruments are credit-impaired, and:

- if the credit risk of the financial instrument has increased significantly since initial recognition, the association measures the loss allowance of the financial instruments at an amount equal to the lifetime expected credit losses and

- if there has been no significant increase in credit risk since initial recognition, the association measures the loss allowance for that financial instrument at an amount equal to ***Please enter number of months***-month expected credit losses.

Simplified approach

The simplified approach does not require tracking of changes in credit risk at every reporting period, but instead requires the recognition of lifetime expected credit loss at all times.

This approach is applicable to:

- trade receivables and

- lease receivables.

In measuring the expected credit loss, a provision matrix for trade receivables is used, taking into consideration various data to get to an expected credit loss (i.e. diversity of its customer base, appropriate groupings of its historical loss experience, etc).

Purchased or originated credit-impaired approach

For financial assets that are considered to be credit-impaired (not on acquisition or originations), the association measures any change in its lifetime expected credit loss as the difference between the asset's gross carrying amount and the present value of estimated future cash flows discounted at the financial asset's original effective interest rate. Any adjustment is recognised in profit or loss as an impairment gain or loss.

Evidence of credit impairment includes:

- significant financial difficulty of the issuer or borrower

- a breach of contract (e.g. default or past due event)

- where a lender has granted to the borrower a concession, due to the borrower's financial difficulty, that the lender would not otherwise consider

- the likelihood that the borrower will enter bankruptcy or other financial reorganisation and

- the disappearance of an active market for the financial asset because of financial difficulties.

Low credit risk operational simplification approach

If a financial asset is determined to have low credit risk at the initial reporting date, the association assumes that the credit risk has not increased significantly since initial recognition and, accordingly, it can continue to recognise a loss allowance of ***Please enter number of months***-month expected credit loss.

In order to make such a determination that the financial asset has low credit risk, the association applies its internal credit risk ratings or other methodologies using a globally comparable definition of low credit risk.

A financial asset is considered to have low credit risk if:

- there is a low risk of default by the borrower

- the borrower has strong capacity to meet its contractual cash flow obligations in the near term and

- adverse changes in economic and business conditions in the longer term, may, but not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations.

A financial asset is not considered to carry low credit risk merely due to existence of collateral, or because a borrower has a lower risk of default than the risk inherent in the financial assets, or lower than the credit risk of the jurisdiction in which it operates.

Recognition of expected credit losses in financial statements

At each reporting date, the association recognises the movement in the loss allowance as an impairment gain or loss in the statement of profit or loss and other comprehensive income.

The carrying amount of financial assets measured at amortised cost includes the loss allowance relating to that asset.

Assets measured at fair value through other comprehensive income are recognised at fair value with changes in fair value recognised in other comprehensive income. The amount in relation to change in credit risk is transferred from other comprehensive income to profit or loss at every reporting period.

For financial assets that are unrecognised (e.g. loan commitments yet to be drawn, financial guarantees), a provision for loss allowance is created in the statement of financial position to recognise the loss allowance.
